

I agree that what I am estimating is vastly different than what the City charges the DDA. I disagree that what DTE is charging is vastly different from what I am estimating.

To break things down a little further, the budget sheet that was shared in our meeting (attached) shows that the Street Lighting estimate for 2022-23 is about \$140,000 for the DTE electricity bills:

The only decorative lights of the 226 total that could be in the DTE – Street Lighting section are the 71 fixtures we have been talking about on the non metered structure. The rest are all DTE utility owned street lights (cobra heads and non DDA decorative), the 11 400W fixtures, and an Automatic Traffic Signal of about \$5k a year that we know are NOT the DDA decorative lights. In our proposal we estimated the cost of electricity of those 71 fixtures at about \$5,500.

So, if you add the \$5,500 from the DTE – Street Lighting line and if you add the rest of the power bills (assuming all charges on all other bills are the remaining DDA decorative fixtures) of \$10,550 you get a total of \$16,050. This is right in line with the estimate of \$14k - \$16k.

I'd be happy to discuss further but what DTE is billing makes sense to me. Please let me know what you think or if you would like to discuss further.

Lori,

According to Mike (which makes sense with our counts) those are on a metered service and not included in the 71 lights. We would be happy to add those 18 or so fixtures in the Water Wheel/Planet Fitness parking lot on Griswold which would adjust our Plan proportionally. I don't think it would be beneficial for DTE to come out or go through the billing because we have a better idea of fixture locations than DTE and have confirmation from them that once we do the conversion the non metered lights will be adjusted to the LED rate. And for the metered fixtures, those bills would adjust upon conversion.

Please let me know if you would like to discuss further. Do you think we are on track to get approval at the next council meeting?

LED Conversion Executive Summary for Northville DDA

Lighting Costs Before and After Conversion

Annualized Current Cost of All Lighting \$7,8021

Annualized Cost of Lighting Year 1 After Conversion \$6,029²

Annualized Cost of Lighting Peak Year After Conversion \$5,4623

ERC pays for maintenance and renewal of the lighting. After conversion, **ERC provides replacement** product at no cost to Northville DDA and <u>ERC pays Northville DDA a maintenance stipend</u> whenever Northville DDA replaces a light. Replacement inventory is provided even if the light fails outside of warranty.

Net Benefit Created by Conversion for Northville DDA

Annualized Benefit Retained by DDA for 1st Full Yr \$1,773 = 22.72% Cost Reduction

Annualized Benefit Retained by DDA for Peak Year \$2,341 = 30.00% Cost Reduction

Total 30 Year Projected Benefit Retained by DDA \$62,354

¹ Electricity \$5,453 + Maintenance \$2,350

² Electricity \$1,010 + Excess Benefit Payment \$5,020

³ Electricity \$1,010 + Excess Benefit Payment \$4,452

Investment by ERC in Northville DDA

Northville DDA has no financial obligation for design, product, or installation. Northville DDA has no out-of-pocket expense whatsoever.

<u>Initial Investment by ERC</u> \$50,197.36 (Initial Optional Buyout Cost – "OBC")

ERC continually invests in the maintenance and renewal of the lighting.

Program Duration

Northville DDA may leave the program without penalty after two years by returning the ERC lighting.

Northville DDA may leave the program any time without penalty by purchasing the lighting.

Lighting may be taken out of the program at <u>any time</u> by non-use. No benefit sharing is due while a facility is closed.

Benefits are re-calculated if hours of use or electricity rates change.

Benefit Sharing with ERC

Payment to ERC Stub Year and 1st Full Year \$418.31/month

Payment to ERC Peak Year \$370.98/month

Benefit sharing with ERC is adjustable if hours of use or electricity rates change, including complete non-use of lighting, in which case no benefit sharing is required.
